South End Community Outreach Ministries:

Thank you for choosing GOODLANDER, SWETT AND RYBICKI to assist with the 2020 taxes for South End Community Outreach Ministries. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will prepare the 2020 federal and state income tax returns for South End Community Outreach Ministries. We will depend on management to provide the information we need to prepare complete and accurate returns. We may ask management to clarify some items but will not audit or otherwise verify the data submitted.

We will perform accounting services only as needed to prepare the tax returns. Our work will not include procedures to find defalcations or other irregularities. Accordingly, our engagement should not be relied upon to disclose errors, fraud, or other illegal acts, though it may be necessary for management to clarify some of the information submitted. We will inform management of any material errors, fraud, or other illegal acts we discover.

We will ultimately adopt, on the behalf of South End Community Outreach Ministries, the alternative selected by management.

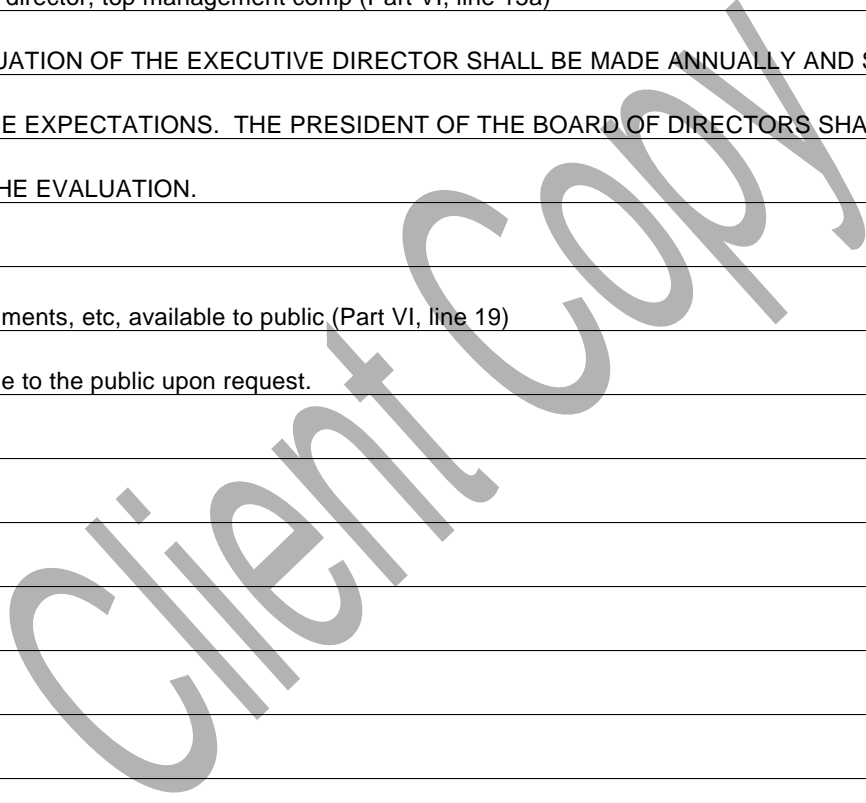
